Why was HAANL Established??

HAANL was established to...

- Lead, support, represent and enhance the Harbour Authorities in Newfoundland and Labrador;
- Provide professional development and training to Harbour Authorities with an overall goal of harbour and economic development; and
- To promote responsible and effective Harbour Authority governance and management.

The Board of Directors

The Board of Directors shall consist of eight (8) members, two (2) from each SCH Area [Eastern Newfoundland; Southern Newfoundland; Central Newfoundland and northern Labrador; and Western Newfoundland and southern Labrador]. When there is insufficient representation in the respective areas, representation will be appointed from other areas. Board members are to be elected by the members from their respective Areas.

Board members shall serve four-year terms.

Vacancies shall be filled by the Board, by a member in good standing for the balance of the term.

The Officers of the Board shall consist of a Chair, Vice Chair, Secretary and Treasurer selected by the Board. One person may serve as Secretary/ Treasurer.

Who can be a member of this organization?

Any Harbour in Newfoundland and Labrador that became a Harbour Authority under the Small Craft Harbours (SCH) Program.

Membership fees shall be \$125.00 per year beginning April 1 and ending March 31.

Each member in good standing present at a meeting of members is entitled to one vote.

Membership is granted, denied or terminated by a simple majority vote of the Board.
